

## **Executive Summary**

Highlights from the Wednesday, October 19, 2022 Board of Directors Meeting

- The Leadership and Advocacy team, comprised of Meshanda Phillips (Student Advocate), Melany Palacios-Naranjo
  (Student Advocate) and Kristine Galvan (Manager, Leadership and Advocacy) presented IGNITE's Advocacy Plan
  initiatives and priorities for the upcoming year. They outlined the 10 critical advocacy actions that IGNITE will prioritize
  over the next 3 5 years in the areas of:
  - Student representation on all institutional committees
  - Increase leadership activities
  - Leverage technology tools to support self-advocacy and the student's campus experience
  - o Student placements to include compensation
  - Increase student participation in program reviews (APR's)
  - Textbook/course load affordability
  - Transparent/predictable tuition framework
  - o Increase access to affordable, culturally diverse foods
  - o Financial resources to support students in need/experiencing financial hardship
  - Advocate for culturally and racially relevant student supports for equity deserving students

They also spoke specifically about IGNITE's participation on a Steering Committee leading an initiative focusing on advocating to the provincial government about the rising costs of international student tuition. IGNITE, in partnership with other student unions such as Sheridan, Mohawk, Centennial and Conestoga are developing plans for a provincial-wide march with other student associations on Thursday, November 17th from 11:00 am to 1:00 pm at Queen's Park to address international student tuition fairness.

the negotiated agreement details that the Board approved as presented.

In summary, IGNITE negotiated a below inflationary and claiming trend increases, under a 6-year term. We are delivering a 24-month rate guaranteed locked in 3 successive terms, with competitive adjustments of +5% and +3% every other year.

• The Governance Review Committee presented draft amendments to IGNITE's By-laws. These amendments are being drafted to adhere to recent changes to the Ontario Non-Profit Corporations Act as well as address the recommendation to include IGS representation on the Board. Specifically, the Board has reached consensus to allocate one representative for the IGS campus, increasing total Board composition to 10 as of 2023-24. The GRC will finalize all amendments and seek formal Board approval by the end of December 2022.
